NUS Law Launches More Prizes & Book Grants

The school adds on four more prizes and book grants to continuously encourage and assist students in their studies.

NUS Law continues to motivate its students to perform well in their studies, and also to ensure that no deserving students get left behind. In doing so, NUS Law has been encouraged by the show of generosity by the school's well wishers in the establishment of new prizes and book grants.

The prizes established are the Mediacorp Prize in Entertainment Law, and the Peacemakers' Prize in Mediation, which will be awarded to the best performing student in Entertainment Law and Mediation module respectively.

For the first time in the history of NUS Law, a graduating class has got together to establish a book grant prior to their graduation. The Class of 2013 Book Grant, which was raised by this year's graduating students, will go to helping financially needy students.

Students who are taking up a law course on Intellectual Property can also look forward to the possibility of being awarded the Isabel Chng Mui Lin Intellectual Property Book Grant.

Following are more details on the individual prizes and grants:

- **Mediacorp Prize in Entertainment Law**

The Mediacorp Prize in Entertainment Law is given to the law student who scores the highest marks in the "Entertainment Law" module. Valued at S\$1,000, the annual prize is sponsored by Mediacorp.

The selection of the recipient will be based on the recommendation of the Faculty's Board of Examiners, after which, the Dean will award the prize to the selected student.

Mediacorp has pledged a total of S\$15,000 to the establishment of this Faculty-level prize, and will go to the award of one prize each year for 15 years.

- **Peacemakers' Prize in Mediation**

The best overall student for the "Mediation" module stands a chance to receive the annual Peacemakers' Prize in Mediation. The S\$1,000 gift is a donation by a group of individuals to establish a prize in Mediation.

The award will be given based on the student's consistency of performance throughout the module as proposed by the convenor. Upon the recommendation of Faculty's Board of Examiners, the Dean will award the prize to the most deserving student.

With the total pledged amount of \$15,000 to NUS Law, the funds will go to the award of one prize annually for a period of 15 years.

- **Isabel Chng Mui Lin Intellectual Property Book Grant**

To commemorate the significant contributions of Isabel Chng '90 to the Singapore Patent System, and to celebrate her zest in life, her friends and colleagues have come together to establish a book grant in her remembrance.

The fund will be used to aid needy Singaporean undergraduate students for the purchase of books. The requirement that recipients of the book grant must fulfill is to have taken, or will be taking up an intellectual property law course (preferably patents related) at the law school.

- **Class of 2013 Book Grant**

The Class of 2013 Book Prize was established with an initial contribution of close to S\$8,000, including a significant contribution from the proceeds of the Law IV musical. The funds contributed will go towards helping financially needy law students.
