Parvathi is a State Counsel in the International Affairs Division ("IAD") of the Attorney-General's Chambers ("AGC"), specialising in areas such as international health law, international human rights law and international criminal law and cooperation. She is involved in, among others, the negotiations on the Pandemic Agreement and amendments to the International Health Regulations. From the time she joined NUS Law, Parvathi had a keen interest in international law and criminal law. She started her career as a Deputy Public Prosecutor in the AGC, where she prosecuted a range of offences in both first instance and appellate courts, and advised law enforcement agencies on matters relating to criminal law. Prior to joining IAD, she was in the International Legal Division in the Ministry of Law, where she negotiated the Model Agreement with the International Tribunal for the Law of the Sea ("ITLOS") for the hearing of ITLOS cases in Singapore, and was actively involved in organising lobbying efforts for the Singapore Convention on Mediation and Singapore's successful bid for re-election to the UN Commission on International Trade Law.
