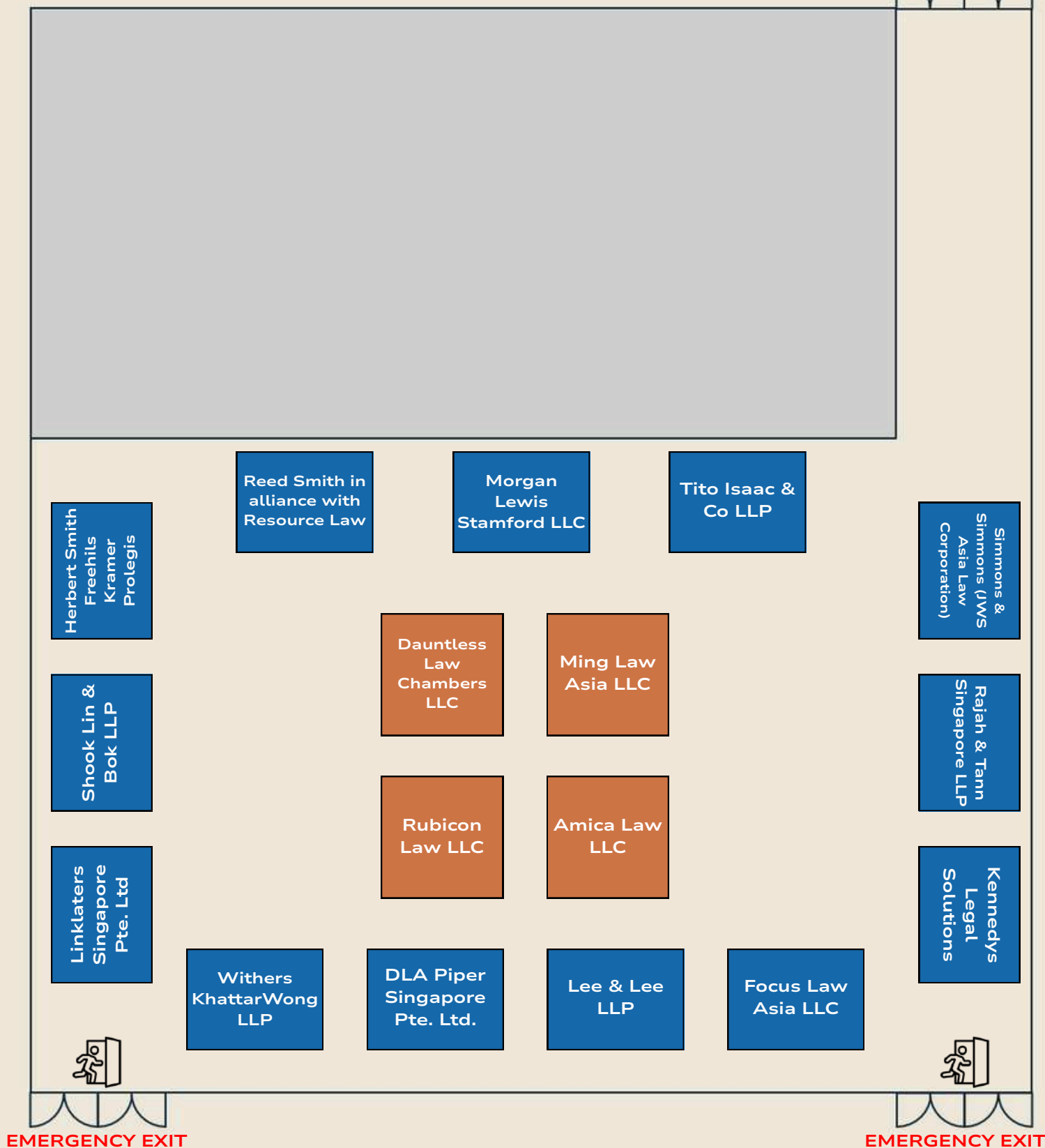

FLOOR PLAN DAY 1



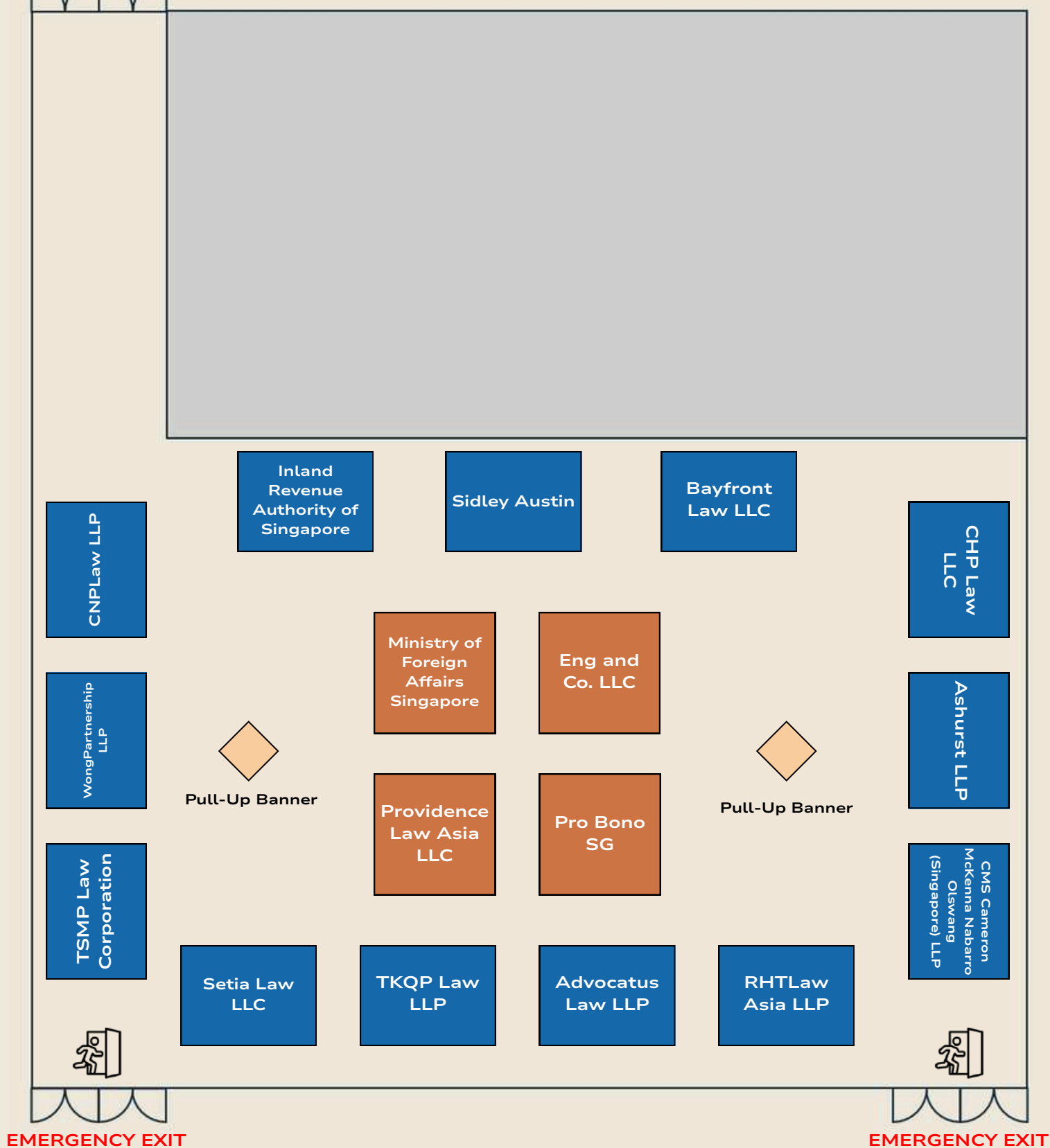
