ABOUT THE SEMINAR

The seminar discusses the the law on contractual interpretation and implication in Singapore following the Court of Appeal decision of *Sembcorp Marine v PPL Holdings*. It will focus on two aspects of the decision.

First, it discusses the new law on contractual interpretation after *Semcorp Marine*. A study of the decisions from *Zurich Insurance to Sembcorp Marine* on contractual interpretation will be discussed and the present law restated. Future possible developments will also be highlighted.

Second, the seminar discusses the new law on contractual implication after *Semcorp Marine*. *Sembcorp Marine* arguably departed from the existing law on terms implied in fact and introduced a new three-step framework for implication. This will be evaluated and future developments highlighted.

ABOUT THE SPEAKER

Goh Yihan is an Assistant Professor at the National University of Singapore, where he teaches and researches in Contract Law and Tort Law. He was formerly a Senior Justices' Law Clerk and Assistant Registrar at the Supreme Court of Singapore. He is a contributor to *The Law of Contract in Singapore* (Academy Publishing, 2012) and a co-author of *Contract Law in Singapore* (Kluwer, 2012). His works have been cited by the Singapore courts. He has also been appointed *amicus curiae* before the High Court (2010) and Court of Appeal (2013). In 2013, he was awarded the Singapore Law Merit Award by the Singapore Academy of Law for his contributions to the advancement and development of Singapore law.
