ABOUT THE SEMINAR

Over the last five years, the Court of Appeal has rendered a number of important judgments in constitutional and administrative law. The issues covered include the concept of equality under Article 12 of the Constitution; the nature of prosecutorial and Presidential discretion; the extent of Article 14 rights to freedom of speech, association and assembly; and the need to call a by-election where a seat in Parliament is vacated. Many of these judgments are ground-breaking both in terms of subject matter and pronouncements on the appropriate tests to be adopted in the determination of constitutionality. This seminar surveys these developments from 2008 to 2013 and considers their impact by an examination and analysis of these judgments.

ABOUT THE SPEAKER

Kevin Tan has taught constitutional and administrative law for over 25 years and is currently Adjunct Professor at both the Faculty of Law, National University of Singapore, and the S Rajaratnam School of International Studies, Nanyang Technological University. He has written and edited over 30 books and 60 articles on the law, history and politics of Singapore. Among his most recent works are: *Constitutional Law in Malaysia & Singapore*, 3rd edition (with Thio Li-ann); *Constitutionalism in Asia: Text, Cases & Materials* (with Wen-chen Chang, Li-nn Thio and Jiunn-rong Yeh); *Introduction to Singapore's Constitution*, 3rd edition; and *Constitutions in Context: Singapore*. He is Editor-in-Chief of the Asian Yearbook of International Law and serves on the Governing Board of the Human Rights Resource Centre for ASEAN (HRRCA).
