In 1997, in consideration of the fact that the international law articles and regular sections in the Singapore Journal of Legal Studies had become well-established, the Singapore Journal of International & Comparative Law was founded in its own right to focus on international law as well as comparative law, which had also come to feature regularly in the Singapore Journal of Legal Studies.

The Singapore Journal of International & Comparative Law has been renamed the Singapore Year Book of International Law beginning with Volume 8 of 2004. However, back issues of the Singapore Journal of International & Comparative Law are still available for ordering.
