#### Message from the Dean

Despite being Dean of NUS Law for more than a decade, the easing of the pandemic has made many events feel fresh and new, since it's the first time we've done them in person for more than two years.

I write this note shortly after one of our most lively prize-giving ceremonies. It is a lovely occasion, at which we recognise some of our best students, thank donors for their support, and provide ample opportunities for proud parents to take photographs. That event is just one example of how life has returned to the Bukit Timah Campus, with in-person classes (masks optional) and student events starting to resemble pre-pandemic times.

And yet, we emerge from the pandemic transformed. We have learned to use technology in different ways. Though I hope that most of our classes will remain "live", we will doubtless continue to "Zoom in" visitors from around the world as and when needed. More generally, we are introducing a new Law & Technology module for all students, which will address not just the regulation of new technologies, such as artificial intelligence (the "law of technology"), but also how those tools are changing legal practice (the "technology of law").

We have also become more conscious of the importance of health, but not just physical health. Awareness of the mental health implications of the pandemic is something that I hope will stay with us, with greater sensitivity to the need for outreach and support, and less stigma associated with asking for help.

For myself, the opportunity to see NUS Law through at least the worst of the pandemic is a blessing of my fourth term as Dean, as is reforming our curriculum to prepare our students for the changing profession. That said, I am delighted that Andrew Simester will be taking over as the fifteenth Dean of NUS Law in January. Andrew is one of the leading scholars of criminal law and theory in the world and an outstanding educator. Over the decade and a half he has been at NUS, he has also shown a deep commitment to mentoring junior colleagues. All of these qualities make me confident that NUS Law is in good hands.

This edition of Law Matters touches on all these topics, with features on an alumnus who was an early mover in the technology space, an alumna whose grit and determination offers lessons for us all, and an introduction to three of our newest colleagues. Enjoy!


