Indonesia's biodiversity is under increasingly serious threat from environmental crimes including illegal logging, illegal mining, national park encroachment and poaching.

In this seminar, Laely Nurhidayah will assess the implementation of biodiversity laws in Indonesia, in particular the national laws and policies aimed at reducing deforestation. Drawing on her findings from multi-year empirical studies and field work in various Indonesian provinces, Laely will highlight the critical challenges to effective implementation, which include overlaps as well as gaps in the legal frameworks, law enforcement, lack of local government capacity, and lack of awareness on the part of the local communities that are deeply affected by the implementation of the laws.

Her research interest areas are international environmental law, marine and coastal governance, and forest governance in Indonesia and climate change adaptation. Prior to her position as a APCEL NUS visiting fellow 2018, she has received several research grants and fellowships.
