#### ROSE-LIZA EISMA-OSORIO PROFESSOR, COLLEGE OF LAW, UNIVERSITY OF CEBU

Rose-Liza Eisma-Osorio is an attorney and professor of law with more than 20 years of extensive experience in natural resources law and regulatory policy. She has led international and national governing councils and non-profits, such as the Governing Board of the IUCN Academy of Environmental Law, Foundation for the Philippine Environment, and Coastal Conservation and Education Foundation. She teaches and researches in environmental law, property law, administrative law, and international environmental law. Her research scholarship areas are concerning the underlying legal and institutional environmental governance framework, marine spatial planning, biodiversity protection, climate change, traditional knowledge, and legal compliance in protected landscapes and marine sensitive areas. She recently joined Oceana in the Philippines as its Legal and Policy Director.

# BEATRIZ GARCIA ASSOCIATE PROFESSOR, LAW, ECONOMICS, AND MANAGEMENT DEPARTMENT, SORBONNE UNIVERSITY ABU DHABI

Beatriz Garcia is a distinguished expert in international and environmental law, with a Ph.D. from the Graduate Institute of International and Development Studies in Geneva. Her research spans climate change law, forest conservation, Indigenous rights, marine pollution, and decarbonization in shipping and other hard-to-abate sectors. She has authored *The Amazon from an International Law Perspective* (Cambridge University Press) and published in leading journals like the *Journal of Environmental Law*. Dr. Garcia has extensive experience working with international organizations, including UNCTAD, UNEP, and UNESCO, and consulting for governments and private entities on climate and sustainability. Previously, she managed projects at UNCTAD and Forests Alive Carbon & Climate Solutions. She is affiliated with key global networks, including the IUCN Academy of Environmental Law and the Abu Dhabi Environmental Research Network. In 2021, she was shortlisted for Alternative Dispute Resolution Academic of the Year by the Australian Disputes Centre.

#### LINDA YANTI SULISTIAWATI SENIOR RESEARCH FELLOW, APCEL, NUS LAW

Linda is a Senior Research Fellow at APCEL and also an Associate Professor of Law in Universitas Gadjah Mada, Indonesia. She received her doctorate in 2013 (honorary mentioned) from University of Washington School of Law, supported by the Fulbright PhD Presidential Program. She focuses on international environmental law issues, such as climate change, REDD+, marine plastic pollution, land issues and customary (adat) issues. Linda was a member of the delegation leading Indonesia's negotiations of the Paris Agreement on Climate Change. From 2018 to 2023, Linda is a lead author of the Intergovernmental Panel on Climate Change's Sixth Assessment Report. Her newest research on Indonesia Climate Related Litigation was published in Nature Communication in September 2024.
