

## Announcing Presenters for the 3rd Asian Law Junior Faculty Workshop 26 to 27 January 2023

The Centre for Asian Legal Studies (CALs) at the National University of Singapore is pleased to announce the selected presenters for the 3rd Asian Law Junior Faculty Workshop (AsLJFW) from 26 to 27 January 2023. Now in its third year, the Asian Law Junior Faculty Workshop has been received with great enthusiasm amongst junior law scholars in the region and around the world. This year, 28 abstracts were chosen from more than 100 submissions and invited to submit their long papers for review.
