2nd Workshop “An Introduction to the Basics of Singapore Company Law”

The Centre for Asian Legal Studies (“**CALS**”), NUS Faculty of Law and Thammasat University Faculty of Law are pleased to announce the Centre for Asian Legal Studies – Thammasat University Faculty of Law Peer Learning Initiative (“**CATPLI**”), a student-led project with the long-term goal of promoting direct knowledge exchange and academic collaboration between the students of both faculties.

CATPLI’s second workshop titled “**An Introduction to the Basics of Singapore Company Law**” seeks to introduce students of Thammasat University (“**TU**”) as well as other Thai law students to the basic principles of company law in Singapore, while providing NUS law students with a platform to consolidate their knowledge in this regard and learn about differences found in Thai company law. The structural differences between the civil law system in Thailand and the common law system in Singapore will present all participants the opportunity to have meaningful discussions of some of the doctrinal differences present in the company laws of both jurisdictions. Following the successful inaugural workshop last year, this year’s workshop seeks to foster a deeper sense of appreciation for each jurisdiction’s approach to company law, with the primary focus on Singapore company law.

There will be a total of seven online sessions in this year’s workshop from 11 March 2023 to 22 April 2023. This course is open to all Thai law students.

- 18 March 2023: Corporate Governance I
- 25 March 2023: Corporate Governance II
- 1 April 2023: Directors' Duties
- 8 April 2023: Resolution of Internal Disputes
- 15 April 2023: Shareholder Liability & Corporate Liability
- 22 April 2023: Tutorial
