

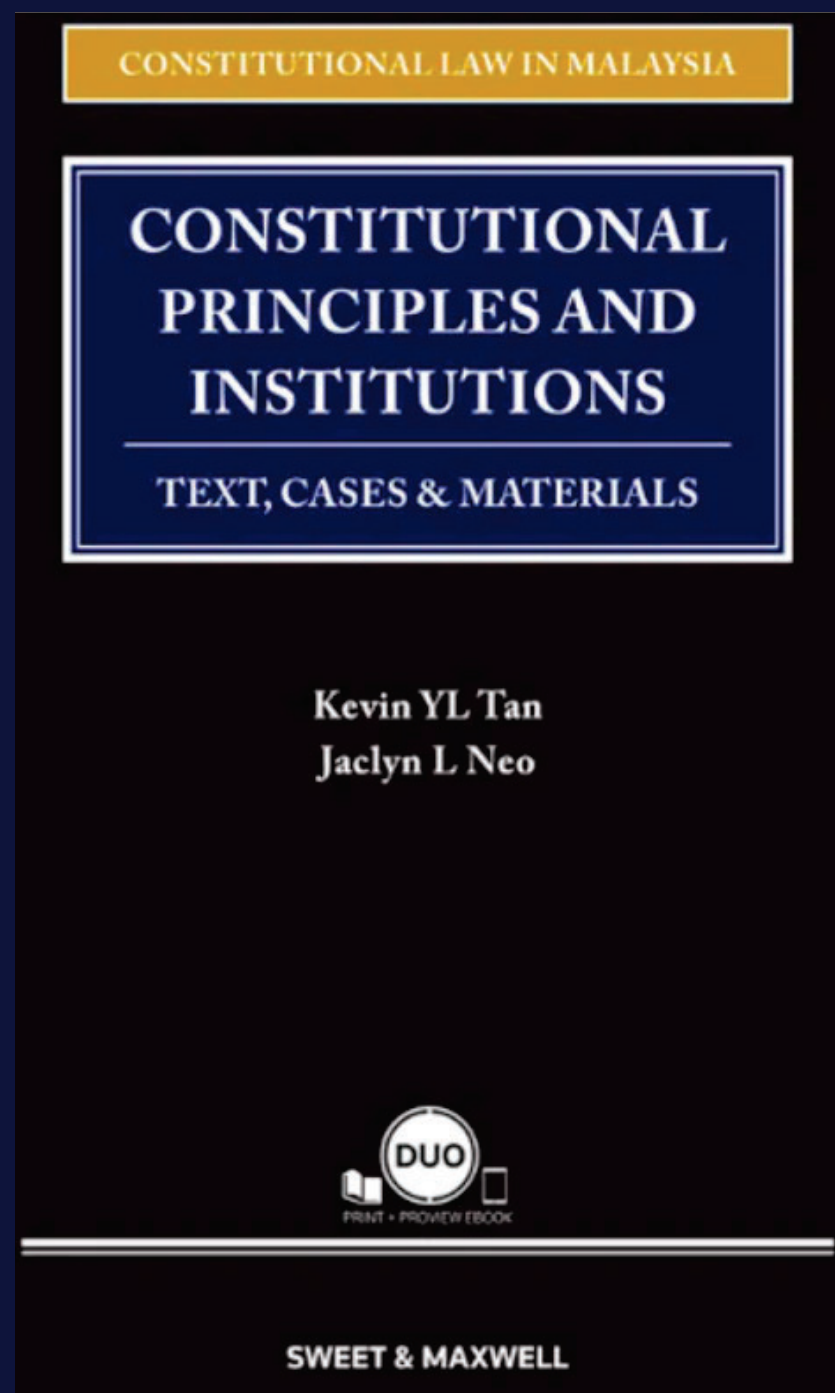

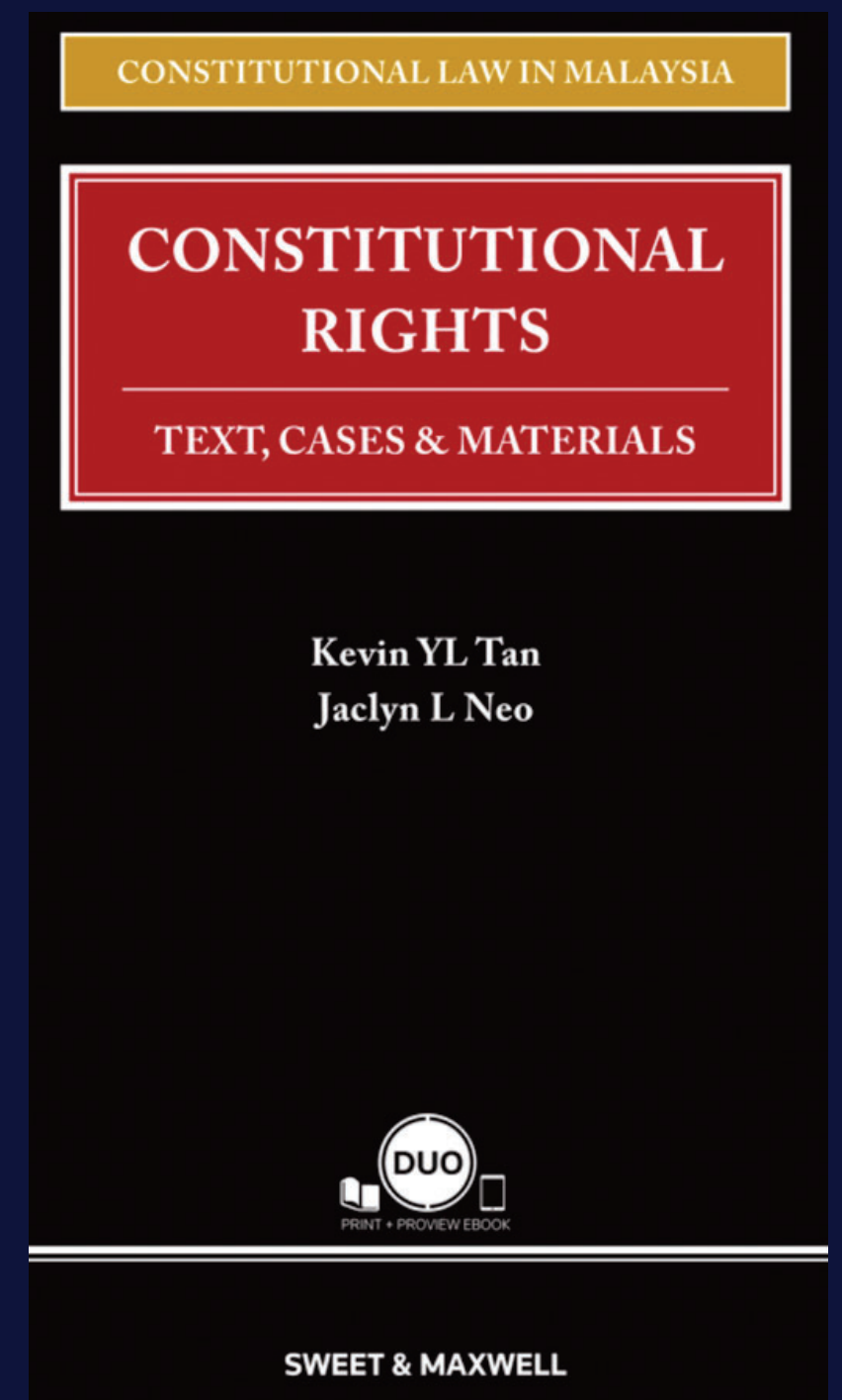

**GUEST-OF-HONOUR:
CHAN SEK KEONG SC (FORMER CHIEF JUSTICE OF SINGAPORE)**

Mr Chan Sek Keong was born in Ipoh and was a member of the inaugural batch of students admitted to the Faculty of Law of the then University of Malaya, now National University of Singapore in 1957. He graduated in 1961 and was admitted to the Bar in January 1962. He practiced as a lawyer for a number of years in Kuala Lumpur and Singapore before being appointed the first Judicial Commissioner of Singapore in July 1986. Two years later, he became a Judge of the Supreme Court of Singapore.



DIAN A H SHAH (ASSISTANT PROFESSOR, NUS LAW)

Dr Dian A H Shah was previously a Research Fellow of the Centre for Asian Legal Studies, and a Senior Lecturer at the Faculty of Law, University of Malaya, where she taught constitutional law. Dian completed her LL.M and SJD degrees at Duke University Law School, and prior to that she graduated with an LL.B from Warwick University. Her research interests span the fields of law and religion, comparative constitutional law, and human rights, and her work focuses on the interaction of law, religion, and politics in plural and divided societies.



JACLYN NEO (AUTHOR, ASSOCIATE PROFESSOR, DIRECTOR OF CENTRE FOR ASIAN LEGAL STUDIES, NUS LAW)

Professor Jaclyn Neo is a graduate of NUS Faculty of Law and Yale Law School and is a scholar of comparative constitutional law as well as law and religion in Asia. She was appointed Director of the Centre for Asian Legal Studies in January 2020. She has published in leading journals in her field, including the International Journal of Constitutional Law (I-CON), the Oxford Journal of Law and Religion, and the Asian Journal of Comparative Law.



KEVIN YL TAN (AUTHOR, ADJUNCT PROFESSOR, EDITOR-IN CHIEF OF ASIAN JOURNAL OF COMPARATIVE LAW, NUS LAW)

Professor Kevin YL Tan specializes in Constitutional and Administrative Law, International Law and International Human Rights. He graduated with an LLB (Hons) from the Faculty of Law at the National University of Singapore and holds an LL.M and JSD from the Yale Law School. He currently holds Adjunct Professorships at the Faculty of Law, National University of Singapore (NUS) as well as at the S Rajaratnam School of International Studies, Nanyang Technological University (NTU) where he teaches constitutional law, international law and international human rights.



SHAD SALEEM FARUQI (EMERITUS PROFESSOR, UNIVERSITY OF MALAYA)

Professor Emeritus Datuk Dr Shad Saleem Faruqi is a Malaysian legal scholar and professor of law at the University of Malaya, currently holding the Tunku Abdul Rahman Chair as Professor of Constitutional Law. He is also the fourth holder of the Tun Hussein Onn Chair in International Studies at the Institute of Strategic and International Studies (ISIS) Malaysia effective July 2019 to June 2021. He is an Emeritus Professor of Law at Universiti Teknologi Mara, Shah Alam. He has served Universiti Teknologi MARA in Shah Alam, Selangor in various capacities from 1971 onwards. He served as the Head of the Diploma in Law programme (1979–1984), as Assistant Rector (1996–1999), Assistant Vice-Chancellor (1999–2001) and Legal Advisor (1996–2006, 2010–2017).
