Professor Ying Khai Liew
University of Melbourne

Ying Khai Liew is a Professor at the Melbourne Law School, University of Melbourne. He teaches and researches in private law, specialising in the law of equity and trusts, the law of assignment, contracts, and remedies.

He is widely published and has been cited by courts around the world including the UK Supreme Court. Ying is the founder of the Asia-Pacific Trusts Law project and the General Editor of the Asia-Pacific Trusts Law book series with Hart Publishing. He is also the author of *Rationalising Constructive Trusts* (Hart Publishing 2017) and of the practitioner's text, *Guest on the Law of Assignment* (currently in its fourth edition, Sweet & Maxwell 2021). Ying is the Associate Director (Private Law) of the Asian Law Centre at the Melbourne Law School, and is also an editor of the *Journal of Equity*.

Hans has taught at the Faculty of Law, NUS, since 1990, and was previously Director of the Centre for Banking and Finance Law and Centre for Commercial Law Studies. He has published widely in international and local journals, and has written or co-written books on company law, securities regulation and trust law. He is also a contributor to *Halsbury's Laws of Singapore* on contract law and to *Palmer's Company Law* (Geoffrey Morse ed).

He was previously seconded to the Monetary Authority of Singapore and the Ministry of Law. He is presently serving on the Securities Industry Council, is Deputy Chairman of the SGX Listing Advisory Committee, and a consultant with TSMP Law Corporation. He has been a visiting professor at National Taiwan University, Auckland and Shanghai's ECUP and a visiting scholar at Stanford and Melbourne. He recently delivered public lectures at the law schools of NTU, Tsinghua and Zhejiang Universities and West Bengal National University of Juridical Sciences.
