JAMES FOONG CHENG YUEN a Former Justice of the Federal Court in Malaysia and also Managing Judge of Penang Courts and the Civil Division of the High Court in Kuala Lumpur. Retired from the Malaysian Judiciary in February 2012 after 22 years as a judge of the Superior Courts in Malaysia. Now a legal practitioner and an arbitrator. Graduated from the University of London with an LL.B degree in 1969 and called to the English Bar by the Honourable Society of the Inner Temple a year later. Called to the Malaysian Bar in 1971. Practiced as an advocate and solicitor in the High Court of Malaya from 1071-1990. Elevated to the High Court Bench as Judicial Commissioner in 1990 and then made High Court Judge in 1992. Became judge of the Court of Appeal in 2005 and then judge of the Federal Court of Malaysia in 2009. Was in the team responsible for the modernization of the

Malaysian Judiciary from 2008. Prepared and implemented the Judicial Institute for superior court judges in Malaysia. Received honourary degree of Doctorate of Law from the University of West of England and made Overseas Bencher by the Honorable Society of the Inner Temple. Now an advocate and solicitor providing legal consultancy services and also an Arbitrator.

AJIT PRAKASH SHAH is a Justice retired as the Chief Justice of the High Court of Delhi in February, 2010. He was appointed as the Judge of Bombay High Court in 1992 and was later elevated to the office of Chief Justice, Madras High Court in 2005 and on transfer took over as Chief Justice, Delhi High Court on 11th May, 2008 till his retirement.

He has delivered several landmark and prominent judgments during his tenure ranging on diverse issues such as: Application of the Right to Information Act to the office of the Chief Justice of India; Decriminalization of homosexuality; Freedom of Speech and Expression; Environment and Ecological matters;

Protection of disabled person; Laws relating to women.

Justice Shah is the Chairperson of the BCCC, self regulatory body appointed by IBF. He is also heading a Committee appointed by the Planning Commission for drafting Privacy Law and Data Protection Law. He is a Member of Governing Council appointed by Ministry of Law & Justice for judicial reforms.



HELENA WHALEN-BRIDGE is an Associate Professor at the National University of Singapore Faculty of Law. She holds a B.A. (University of Connecticut, 1981), J.D. (University of Connecticut, 1985), and LL.M. (National University of Singapore, 2002). Helena's professional career began as Law Clerk in the U.S. District Court (E.D.Ca.), followed by five years of jury trials and appeals as Deputy Attorney General, California Attorney General's Office. After acting as In-House Counsel in Japan and Singapore, Helena joined the NUS Faculty of Law.
