REHAN ABEYRATNE is an Assistant Professor of Law at the Jindal Global Law School, where he has taught since 2011. He also serves as Assistant Dean (Research and Global Initiatives) and as Executive Director of the Centre for Public Interest Law. He has a B.A. in Political Science from Brown University and a J.D. from Harvard Law School.

Prior to joining JGLS, Prof. Abeyratne was a Holmes Public Service Fellow at the International Justice Network in New York City, where he represented detainees in habeas corpus proceedings before the U.S. federal courts. His previous experience includes work for the International Criminal Tribunal for the Former Yugoslavia, the Extraordinary Chambers in the Courts of Cambodia, and in NGOs in Sri Lanka, Thailand and Burma.

Prof. Abeyratne's research focuses on comparative constitutional law, jurisprudence, and international criminal law. He is admitted to the Bar of the State of New York.



ADAM CATHCART is Lecturer in Chinese history at University of Leeds. He received his Ph.D. from Ohio University and completed his dissertation on Chinese responses to the U.S. occupation of Japan. His article 'To Serve Revenge for the Dead,' based on Beijing archival documents, won China Quarterly's 2010 Gordon White Prize.

He has previously taught at Pacific Lutheran University and Sichuan University. Cathcart maintains an active research program with respect to the Korean War and Sino-North Korean relations and edits the web journal SinoNK.com. He spent last year teaching at Queen's University in Northern Ireland.



MARK CAMMACK is Professor of Law at Southwestern Law School where he has taught since 1990. He has a B.A. from Brigham Young University and J.D. from the University of Wisconsin where he was also a graduate student in Southeast Asian History. He also worked for three years as an Assistant District Attorney in New York. In 2002 Professor Cammack was appointed by the United Nations to observe the trials before the Ad Hoc Human Rights Court for East Timor in Jakarta, and in 2010 he was a Senior Fulbright Scholar in Indonesia.

His research focuses criminal law and procedure and the Indonesian legal system. He is coeditor with Michael Feener of *Islamic Law in Indonesia: Ideas and Institutions* (Harvard, 2007) and author of *Advanced Criminal Procedure in a Nutshell* (West, 2d ed. 2006) as well as numerous articles and book chapters.



WUI LING CHEAH holds an LLM from Harvard Law School. For her Harvard studies, she was recipient of a National University of Singapore Scholarship and the Kathryn Aguirre Worth Memorial Scholarship. She also holds an LLB and an LLM (by research) from the National University of Singapore. She is currently on study leave, and is reading for a DPhil in Socio-Legal Studies at Oxford.

Her research interests lie in the areas of criminal justice, human rights law, and constitutional liberties, and she is particularly interested in transitional justice issues related to Southeast Asia. She teaches at the National University of Singapore, and has conducted fieldwork in Cambodia, Timor Leste, Indonesia, and Japan. Prior to joining academia, Wui Ling served as a legal officer at Interpol (General Secretariat, Lyon) and as a legal trainee at the Serious Crimes Unit (Timor Leste).



SIMON CHESTERMAN is Dean of the National University of Singapore Faculty of Law. He is also Editor of the *Asian Journal of International Law* and Secretary-General of the Asian Society of International Law.

Educated in Melbourne, Beijing, Amsterdam, and Oxford, Professor Chesterman's teaching experience includes periods at the Universities of Melbourne, Oxford, Southampton, Columbia, and Sciences Po. From 2006-2011, he was Global Professor and Director of the New York University School of Law Singapore Programme.

Prior to joining NYU, he was a Senior Associate at the International Peace Academy and Director of UN Relations at the International Crisis Group in New York. He has previously worked for the UN Office for the Coordination of Humanitarian Affairs in Yugoslavia and interned at the International Criminal Tribunal for Rwanda.

Professor Chesterman is the author or editor of twelve books, including *One Nation Under Surveillance* (OUP, 2011); *Law and Practice of the United Nations* (with Thomas M. Franck and David M. Malone, OUP, 2008); *You, The People* (OUP, 2004); and *Just War or Just Peace?* (OUP, 2001). He is a recognized authority on international law, whose work has opened up new areas of research on conceptions of public authority — including the rules and institutions of global governance, state-building and post-conflict reconstruction, and the changing role of intelligence agencies.



ROBERT CRYER obtained his undergraduate law degree in Cardiff Law School, then moved to the School of Law in Nottingham where he obtained his LLM and PhD degrees. He was a lecturer in the University of Manchester from 1999–2001 before returning to the University of Nottingham in September 2001. He took up a chair in international and criminal law in the University of Birmingham in April 2007. His major teaching and research interests are in international law and criminal law. In addition to a number of articles and book chapters he is the author of *Prosecuting International Crimes: Selectivity and the International Criminal Law Regime* (CUP, 2005) and co-author (with Håkan Friman, Darryl Robinson and Elizabeth Wilmshurst) of *An Introduction to International Criminal Law and Procedure* (CUP, 2nd ed., 2010) and (with Neil Boister) *The Tokyo International Military Tribunal: A Reappraisal* (OUP, 2008). He also co-edited (with Neil Boister) *Documents on the Tokyo International Military Tribunal* (OUP, 2008). He is co-editor of the *Journal of Conflict and Security Law*.



TARA GUTMAN holds Bachelor of Arts (Asian Studies)/Laws from the University of New South Wales and is now an SJD candidate at the Australian National University. Tara has practised law in Sydney and Phnom Penh. She worked pro bono with the Cambodian Government task force that established the current Khmer Rouge trials, from 2003-2006. In Cambodia, Tara also: developed training courses in international law for the legal profession on behalf of UNDP; taught international humanitarian and international criminal law at the Royal University of Phnom Penh; and ran training courses on international criminal tribunals for Radio Free Asia in Phnom Penh and Washington DC.

Tara has been a Visiting Professional at the International Criminal Court and a Visiting Scholar at George Washington University in Washington DC.



MUHAMMAD RAFIQUL ISLAM is currently a Professor of Law at Macquarie Law School, Macquarie University, Sydney. He studied Economics and Law at The University of Rajshahi, Bangladesh and obtained BA Honours and MA in Economics and LLB with first class. He also obtained LLM and PhD, both in International Law and by major research, from Monash University, Australia, under the Monash Graduate Scholarships. Prior to joining Macquarie University in February 1991, Professor Islam served as an Associate Professor and Chairman of the Department of Law at The University of Rajshahi and Head of the Department of Law at the University of Papua New Guinea. Professor Islam has been an active legal researcher, who has published extensively in his areas of teaching and research interest, mostly in public international law. His recent publications in the main include: *An Introduction to International Refugee Law* (Martinus Nijhoff, 2013); and *International Law: Current Concepts and Future Directions* (LexisNexis Australia, forthcoming 2013).

Professor Islam was awarded the 'Outstanding Teacher Award' by Macquarie University in 2000 for his contributions to teaching and higher degree research supervision and administration.



NEHA JAIN is an Associate Professor at the University of Minnesota Law School. Her scholarship focuses on public international law, criminal law, legal theory, and comparative law. She received a B.C.L. and D.Phil. in Law from Oxford University where she was a Rhodes scholar. She has served as a law clerk to former Chief Justice V.N. Khare of the Supreme Court of India, worked as a research fellow at the Max Planck Institute for Foreign and International Criminal Law, and interned in the Prosecutor's Office at the Extraordinary Chambers in the Courts of Cambodia. Her work has been published in the *European Journal of International Law*, American Journal of Comparative Law, Chicago Journal of International Law, and Duke Journal of Comparative and International Law.



BING BING JIA is a Professor of International Law, Tsinghua University Law School, 2004-present; Legal Officer, UN ICTY and ICTR, 1998-2004; Law Clerk, UN ICTY and ICTR, 1996-1998. Member of the Editorial Board of *Journal of International Criminal Justice*, Chinese Journal of International Law, and the International Review of the Red Cross.



NINA JOERGENSEN is an Associate Professor at the Faculty of Law of the Chinese University of Hong Kong since 2010. She previously worked for eight years in different capacities (prosecution, judges' chambers, defence) at the Special Court for Sierra Leone in Freetown and The Hague, the Extraordinary Chambers in the Courts of Cambodia in Phnom Penh, and the International Criminal Tribunals for the Former Yugoslavia and Rwanda in The Hague and Arusha respectively.

She has also worked for the OSCE Office for Democratic Institutions and Human Rights in Warsaw as the legal adviser for tolerance and non-discrimination. Prior to these assignments, she was a post-doctoral research fellow in international criminal law at the University of Leiden after obtaining her D.Phil. (1998) from the University of Oxford. She has a current practising certificate as a barrister and is a door tenant at Argent Chambers in London.



KOMARIAH EMONG SAPARDJAJA is Professor of Criminal Law in the Faculty of Law at Padjajaran University in Bandung, West Java. She was a Justice on the Supreme Court of Indonesia from 2007 until July this year. Prior to her appointment to the Supreme Court, Dr. Komariah served as an Ad Hoc Judge for the Human Rights Court in Jakarta from 2001 to 2006. She earned her law and doctoral degrees from Padjajaran University, and has lectured there and at other Indonesian universities since 1997.



ABDUR RAZZAQ is the Chief of the Defence Team at the International Crimes Tribunal, Dhaka, Bangladesh where he leads a team defending opposition leaders who are being tried on allegations of committing international crimes. Mr. Razzaq has represented 4 defendants in the 5 trials concluded before the International Crimes Tribunal, Dhaka and is currently representing all the defendants in the appeals pending before the Supreme Court.

Mr. Razzaq was called to the Bar of England and Wales in 1980. He practised in the Superior Courts of England, including the Court of Appeal, from his professional chambers at Lincoln's Inn, London (1982-1985) before returning to Bangladesh in 1986. Mr. Razzaq is one of the leading Senior Advocates of Bangladesh and has over the years successfully conducted many important cases of constitutional importance, including public interest litigations. He has also defended Ministers and Members of Parliament in high profile cases of corruption, tax evasion and money laundering. Mr. Razzaq has attended many international conferences and seminars. Most recently he was invited to speak at Georgetown University, Washington DC. He occasionally writes for the newspapers.



KIRSTEN SELLARS is currently Research Fellow at the Centre for Asian Legal Studies at the National University of Singapore's Faculty of Law. She focuses on Asian perspectives on public international law, with a particular interest in international aggression and uses of force, international criminal law, and law of the sea. Her route into academia began with journalism, having written on international affairs and other issues for newspapers and publications including *The Times, Guardian, New Statesman, Spectator*, and *Los Angeles Times*.

Her first book, *The Rise and Rise of Human Rights*, was nominated in the *New Statesman* as one of 2002's books of the year, and was translated into Korean as *In-gwon Geu Wiseon-eui Yeoksa* (tr. Seung-hoon Oh, Eunhaengnamu, 2003). Her latest book, *'Crimes Against Peace' and International Law*, has just been published by Cambridge University Press. She has also contributed to the *Journal of International Criminal Justice*, *European Journal of International Law*. *Edinburah Law Review* and *International*



LISETTE SCHOUTEN is a PhD candidate at the Graduate Programme for Transcultural Studies, Heidelberg University. Within the University's Cluster of Excellence 'Asia and Europe in a Global Context', she is associated with the Junior Research Group: Transcultural Justice: Legal Flows and the Emergence of International Justice within the East Asian War Crimes Trials, 1946-1954. Lisette's research focuses on Dutch post-war crime trial policy in the Dutch East Indies and Japan, 1945-1955. She holds a Master of Arts in History (2009) from Leiden University where she participated in the MA Europaeum Programme in European History and Civilisation (Leiden, Paris and Oxford).



YUMA TOTANI earned her Ph.D. in history at the University of California, Berkeley, in 2005, and is currently an associate professor of history at the University of Hawaii. She authored *The Tokyo War Crimes Trial: The Pursuit of Justice in the Wake of World War II* (Harvard University Asia Center, 2008) and produced its expanded Japaneselanguage edition, *Tōkyō saiban: dai niji taisen go no hō to seigi no tsuikyū* (Misuzu shobō, 2008).



JUDICIAL COMMISSIONER LIONEL YEE

Mr Lionel Yee is a Judicial Commissioner of the Singapore Supreme Court. He was Singapore's Second Solicitor-General from 1 January 2011 to 31 January 2013 and was appointed a Senior Counsel in 2013. Between July 2008 to May 2012, Lionel was Director-General of the International Affairs Division in the Attorney-General's Chambers of Singapore. He has also served as Legal Advisor in the Permanent Mission of Singapore to the United Nations in New York and has represented Singapore in legal disputes before the International Court of Justice, the International Tribunal of the Law of the Sea and a Dispute Settlement Panel of the World Trade Organization.

Lionel graduated with a Bachelor of Arts degree in Laws from the University of Cambridge and with a Master of Laws (International Legal Studies) degree from New York University School of Law.
