Independent Directors in Asia

Although there is a significant literature on independent directors generally, the vast majority of it views this ubiquitous corporate governance mechanism through an Anglo-American (Western) lens. While independent directors have been transplanted into all of Asia's leading economies, there has been no detailed comparison of the role that independent directors play (or should play) in Asia's leading economies. This project seeks to fill this gap in the literature by bringing together leading comparative and Asian corporate law scholars to undertake a comparative analysis of the meteoric rise of independent directors in Asia. In the process, it aims to re-evaluate several foundational theories in comparative corporate law.

Criminal Law in Myanmar

This project brought together a team of leading criminal law scholars to study the current state of the criminal law of Myanmar and, where needed, to recommend reform of the law. The team conducted three field trips to Myanmar, meeting the Attorney-General, judges of the Supreme Court and the Constitutional Court, law professors at the University of Yangon and University of Mandalay, and senior legal practitioners working in the area of criminal law and criminal justice. The result of the team's work was a seminal book on *Criminal Law in Myanmar*. This book is the first of its kind in Myanmar and promises to be a leading reference text on criminal law for government officials, judges, legal practitioners and students for years to come.

Constitutional Pluralism in Southeast Asia

Southeast Asia is a region of great demographic, ethnic, linguistic, religious and cultural diversity. The legal systems in the region are considerably diversified and offer empirical intra- and inter-state case studies for "legal pluralism". This plurality also manifests itself in the constitutional arrangements of the various Southeast Asian states. The research hypothesis is that the constitutional design and practices of Southeast Asian states is best understood as conforming to "constitutional pluralism". This research project employs the theory of constitutional pluralism to develop an analytical framework through which to examine the range of plurality and their influence on constitutional design and practice in the region.

Law, Authoritarianism, and Democracy in Asia

In the past 150 years, Asia has seen the rise and fall of many authoritarian regimes within its region. Some have transitioned to fully democratic states while others remain as semi or fully authoritarian states with varying levels of commitment to the rule of law. Yet, both types of regimes have legal systems that are considered to be legitimate. This project aims to further the research and the literature surrounding the concept of authoritarian legality. As a means of conceptualising a regime's legal legitimacy, "authoritarian legality" denotes the political and legal order that exists within an authoritarian state. In other words, the concept of authoritarian legality postulates that authoritarian regimes can have legal systems that commit to normative constitutionalism. This lies in sharp contrast to the neoliberal ideals of political liberalisation and the separation of powers.






