Dr. Vincent-Joël Proulx is Associate Professor at the National University of Singapore's Faculty of Law, where he teaches and researches primarily in the areas of international law, international dispute settlement, counterterrorism, international and national security law, and comparative law. He is the Director of the LL.M. Programme in International Arbitration and Dispute Resolution. He was awarded the faculty-level Annual Teaching Excellence Award for the 2018-2019 academic year. Previously, he served a three-year term as Special Assistant and Legal Adviser to the President of the International Court of Justice (ICJ) in The Hague. His past appointments also included serving as Legal Officer to the Vice-President of the ICJ, Law Clerk at both the Court of Appeal for Ontario and ICJ, Québec Scholar at the Woodrow Wilson International Center for Scholars, and Secrétaire-rédacteur at five sessions of the International Law Institute. He has also held various positions at the Canadian Department of Foreign Affairs and International Trade, Industry Canada, the Office of the General Counsel of the Information Commissioner of Canada, and McGill University's Centre for Human Rights and Legal Pluralism. Given his expertise in international dispute settlement and international law, he was appointed to the European Union's List of Candidates Suitable for Appointment as Chairpersons for Arbitrations, the List of Arbitrators of the Hong Kong International Arbitration Centre (HKIAC), the Reserve Panel of Arbitrators of the Singapore International Arbitration Centre (SIAC), and the Panel of Arbitrators of the Asian International Arbitration.

Vincent-Joël is the author of Institutionalizing State Responsibility: Global Security and UN Organs (Oxford University Press 2016) and Transnational Terrorism and State Accountability: A New Theory of Prevention (Hart Publishing 2012), for which he was awarded the 2014 Myres S. McDougal Prize for best book in Law, Science, and Policy by the Society of Policy Scientists. His contributions have also appeared in various leading publications, including the American Journal of International Law Unbound, European Journal of International Law, Harvard National Security Journal, Journal of International Dispute Settlement, Leiden Journal of International Law, and Michigan Journal of International Law. He is a member of the Editorial Committee of the Singapore Journal of Legal Studies. His co-authored paper, titled 'Requiem for a Deal, or the End of American Influence in the Investment Chapters of Asia-relevant FTAs?', was awarded the Best Paper Award by the Japan Chapter of the Asian Society of International Law at its 2018 Global Annual Conference. His scholarship has been featured in the Chronicle of Higher Education, assigned as compulsory or recommended reading in various syllabi in law and other disciplines, produced as evidence in proceedings before the ICI, and widely cited in different languages, including by the Supreme Court of Israel in its targeted killing decision, the United Nations Special Rapporteur on Counter-Terrorism and Human Rights, the Special Rapporteur of the International Law Commission on the identification of customary international law, and in reports by the International Bar Association Task Force on Terrorism and the International Law Association Committee on Nuclear Weapons, Non Proliferation and Contemporary International Law.

Vincent-Joël is a Member of the Executive Council of the Asian Society of International Law (second term), the Executive Committee of the Asia-Pacific Centre for Environmental Law (APCEL), and the Board of Experts of Talking about Terrorism, a non-partisan Washington DC-based think tank. He is also a Member of the International Law Association Study Group on Individual Responsibility in International Law. Vincent-Joël has presented his work at various leading international conferences, workshops, and public lectures in Asia, Europe, North America, and Australia. He served as invited faculty member at the last five editions of the Singapore International Arbitration Academy (SIAA), teaching sessions on general rules of international law and the investment treaty regime. He was also appointed Director of Studies of The Hague Academy of International Law 2022 winter session (French section). Since 2015, he has served as Rapporteur for Oxford International Organizations (OXIO) given his expertise in international law and the law of international organizations.

Vincent-Joël has taught several classes as a guest lecturer at law faculties in Asia, Australia, Europe, and North America. He has instructed high-level government officials from around the world in training sessions on foundational and more advanced issues in international law, international investment and commercial arbitration, and international dispute settlement convened by the Singaporean Ministry of Foreign Affairs, National University of Singapore's Centre for International Law, and Singapore International Arbitration Centre (SIAC). He holds LL.L. and LL.B. degrees (cum laude) from the University of Ottawa, an LL.M. in International Legal Studies from NYU School of Law, and a doctorate in international law from McGill University, where he was the recipient of several awards and scholarships.
