RECENT RESEARCH PROJECTS

- The Great Rule of Law Fallacy: Rethinking Legal Modernization in Taiwan and South Korea (manuscript in preparation): This book project challenges the modernization theory in law, which asserts that authoritarian regimes embracing the rule of law would eventually democratize. Revisiting Taiwan and South Korea—two textbook cases of legal modernization theory—it analyzes state-law interactions during the Cold War within the broader context of Asian geopolitics. In doing so, it exposes the flaws of conventional theories and the limitations of global rule of law promotion, particularly in China.
- "Alternative Regime, Same Institutions? How Transnational Law Fuels China's Resilient State Capitalism" This book project analyses how China has been able to piggyback transnational legal regimes thus far to distribute legal and business risks globally, thereby increasing risk-taking ability for the sake of its state capitalism. It focuses on global capital market, insolvency, financial institutions and RMB internationalization.
