NUS Law

The National University of Singapore Faculty of Law (NUS Law) is Asia's leading law school. Staffed by an outstanding permanent faculty diverse in origin and qualifications, NUS Law is dedicated to building a vibrant community and creating an environment that facilitates critical thinking and reflection on the fundamental legal issues confronting our interconnected world. Located in Singapore, which for more than a century has been a commercial hub at the crossroads of Asia, NUS Law is very much Asia's Global Law School.

Since 1957, the school's curriculum has been infused with perspectives from other jurisdictions and disciplines. This tradition has accelerated in recent years, providing a legal education that is comparative, international and multidisciplinary. NUS Law hosts many visiting faculty and students from every continent, offering a lively, cosmopolitan atmosphere both inside and outside the classroom. The strength of the NUS Law curriculum lies in the broad and diverse range of subjects it offers. In addition to a rigorous core curriculum, students can choose from more than a hundred electives in areas such as Asian legal studies, international and comparative law, commercial law, IP and technology law, law and society, legal theory, maritime law, and public and private international law.

Dean's Message



"Think about how your chosen course of study will equip you for wherever your life may eventually lead."

What to study, and where to study it? These are two of the more important decisions you will make across your life. The choices of degree and university may seem daunting. However, as you contemplate your course of study, I urge you to think broadly. Rather than thinking about it as buying a ticket to a career, think about how your chosen course of study will equip you for wherever your life may eventually lead.

For many, the destination lies in practice. NUS Law graduates occupy the highest legal offices in the land: they include the Chief Justice, the Attorney-General, and senior practitioners in all areas of law. Our alumni include partners in top international firms in New York and London, Hong Kong and Shanghai.

For others, life may lead them beyond the law. Some of our graduates assume public office, like former President Halimah Yacob and Law Minister Edwin Tong. Others join academia or represent Singapore on the international stage, like former Dean and Ambassador-at-Large Tommy Koh (who did both). Still others use their legal training to start new ventures in the corporate world, like Tan Min-Liang, CEO of gaming giant Razer, or apply their skills with language as playwrights or actors, like Eleanor Wong—who is the Associate Provost (Special Projects) at NUS Law—and Ivan Heng.

But one thing you should consider in your decision is the very experience of journeying on that path. The problem-solving and argumentation skills required to be a successful lawyer are also life skills, skills that will stand you in good stead wherever your journey takes you. NUS Law offers rigorous legal training, but we also teach personal and professional skills that enable our graduates to operate across boundaries. That includes national boundaries, through the chance to spend a semester or even your entire third year at law schools in some twenty countries, or your fourth year earning a Master of Laws degree from New York University, King's College London, or other leading institutions. We also cross disciplinary boundaries: you may take subjects outside law from across the University—in some cases leading to a second degree. Law is a versatile degree. Our graduates are to be found working not only in professional law firms but also in government, in commerce, in charities and beyond.

Your journey will also be interactive. At NUS Law, you will not merely be a student but a participant. Our professors expect you to challenge them, to share new ideas and to debate different perspectives. Many legal problems do not have solutions that you can look up in a statute or even a textbook. As such, they present an opportunity to persuade the professor, or the court, that your answer is better even when there are plausible alternatives. Law, in other words, is not just about the answers. It is about how you get to them. We don't aim, then, to produce "lawyers". We aim to produce leaders who can be successful in whatever path they choose.

You have some important decisions to make. Whatever your choices, we hope that they will be right for you.

NUS Law is Asia's Global Law School—a place where law is studied not just as a set of rules, but as a dynamic, evolving field driven by people, ideas and the challenges of a changing world. Rooted in Asia and connected globally, the Faculty brings together leading researchers, practitioners and students in a vibrant, collaborative learning community.

The NUS Law Legacy

NUS Law's story began in 1956, when the Department of Law was established at the then University of Malaya. A year later, the first cohort of law students arrived, beginning a tradition of legal education that would shape Singapore's legal landscape.

In 1959, the department became a Faculty under its founding Dean, the late Professor Lionel Astor ("Lee") Sheridan, whose vision laid the foundations for academic rigour and intellectual curiosity that continue to define NUS Law today.

The pioneer class graduated in 1961, many of whom would go on to leave a lasting impact on Singapore's legal and public institutions, including Professor Tommy Koh (Ambassador-at-Large and former Dean), former Chief Justice Chan Sek Keong, the late former Dean Thio Su Mien and

Emeritus Professor Koh Kheng Lian—names that still resonate within the law school and beyond.

The progress of the law school has evolved alongside the growth of Singapore. In 1962, the University of Singapore was formed as an autonomous national university, and in 1980 it merged with Nanyang University to become the National University of Singapore. As part of the modern NUS, NUS Law has continued to educate generations of lawyers, advance the law and prepare graduates to serve society in Singapore, across Asia and around the world.

Today, every student who joins NUS Law becomes part of this continuing story—building on the legacy of those who came before and shaping the future of law.

Law Club

The NUS Students' Law Club (Law Club) is a constituent club of the NUS Students' Union (NUSSU) and is made up of Law undergraduates. The Law Club Management Committee and its subsidiary clubs organise events throughout the year. These range from the Law Careers Fair to Open Day, Block B party and other social events on campus.

Law Sub-Clubs



Collaborative Dispute Resolution Club

The Collaborative Dispute Resolution Club (CDRC) aims to promote alternative dispute resolution (ADR) skills amongst students, such as through mediation and negotiation. CDRC also represents NUS at various international ADR competitions, where CDRC teams have consistently won multiple awards. The club's strong culture of knowledge-sharing ensures that every generation learns from the best.



Justified

Justified is a student sub-club that chronicles happenings around the school and beyond on its website. Besides event coverage, it also covers an array of other interesting stories, ranging from food reviews and lifestyle articles to creative pieces written by students.



Law Students' International Relations Committee

The NUS Law Students' International Relations Committee (LSIRC) engages international students through events and activities that introduce our foreign friends to Singapore and help them integrate into the school community. LSIRC also plans internal school events, such as panel discussions on international law (e.g. Practice Beyond Borders, Careers in International Law), and welfare parties. LSIRC is a local chapter of the Asian Law Students' Association (ALSA) Singapore which organises cross-border bonding activities and legal conferences.



Mooting & Debating Club

The Mooting & Debating Club (MDC) promotes oratorical skills and the passion for mooting, debating and advocacy among Law students.

The MDC is responsible for working with leading law firms to organise various local moot competitions, such as the B.A. Mallal Moot, the Advocacy Cup, the WongPartnership International Commercial Arbitration Moot, TSMP Moot & Mingle and the CMS IP Moot. It also hosts a series of sessions for members to engage in informal debates and discussions.

The MDC also focuses on nurturing each new generation of mooters through its robust training and mentorship programme, affording aspiring mooters support for crucial advocacy skills. The MDC's flagship Young Mooters Programme provides students with invaluable opportunities to develop further and cut their teeth on mooting (on a not-for-academic-credit basis) at international competitions.



NUS Criminal Justice Club

'In Truth and Justice' is the guiding motto of the Criminal Justice Club (CJC). The CJC's mission is to instill in its members a passion for criminal law, with a particular focus on pro bono criminal practice and fostering engagement across multiple disciplines. The club facilitates collaboration and internships with key institutions, including the Criminal Legal Aid Scheme (CLAS) Fellowship, Pro Bono SG, the Public Defender's Office and the Attorney-General's Chambers. It also offers workshops and dialogues with distinguished guests, providing opportunities for members to engage with contemporary issues in criminal law.

In pursuit of these goals, CJC organises a few flagship projects a year: CJC Forensics, The Recourse Initiative, Military Justice Project and CJC-CLAS Initiative.



NUS Pro Bono Group

The NUS Pro Bono Group (PBG) is a student-run organisation dedicated to the promotion of pro bono service among Law students. PBG aims to promote access to justice through its various projects, ranging from legal clinic attachments to court assistance (with the State Courts and Syariah Courts). Furthermore, PBG initiates community outreach programmes, working with various entities such as the Ministry of Manpower and the Financial Industry Disputes Resolution Centre, to assist different beneficiaries.

Apart from its 10 projects, PBG also organises its annual flagship event—Pro Bono Awareness Week—to expose the law school population to the pro bono culture in NUS Law and, more widely, in Singapore. In addition to local efforts, PBG's impact extends overseas. One example is our long-standing partnership with Thammasat University for "Thai-Ed with Love", where NUS Law students have the rare opportunity to learn more about pro bono culture in Thailand and to engage in pro bono work there.



Singapore Law Review

The Singapore Law Review (SLR) is Asia's oldest student-run legal publication, managed exclusively by the students of the National University of Singapore, Faculty of Law. Founded in 1959, the SLR provides a platform for legal scholarship and aims to raise awareness of current legal issues; promote critical legal thinking, writing, and discussion amongst students, academics and members of the legal fraternity; and empower the SLR members to hone their own editing and writing skills.

The SLR publishes an annual journal which features articles written by Justices of the Supreme Court, eminent scholars, legal practitioners, and law students from Singapore and abroad. The SLR also manages an online legal newsletter, *Juris Illuminae*. Beyond these publications, the SLR organises an annual lecture featuring legal luminaries on topics of their specialisation or interest.

Environmental Law Students Association

The Environmental Law Students Association (ELSA) is a student-led interest group affiliated with the Asia-Pacific Centre for Environmental Law (APCEL). Founded in 2016, ELSA champions student-led research and advocacy that fosters environmental consciousness in all areas of the law. The group strives to become the undergraduate centre in environmental law and policy, anchored in Singapore but with a continuing interest in Southeast Asia and the broader Asia-Pacific region. Its vision is to shape a generation of environmentally conscious legal professionals with a heart for intergenerational justice.



Spaces@BTC

Spaces@BTC focuses on improving mental wellness among Law students and fostering a more compassionate environment in law school. In addition, Spaces@BTC raises general awareness of mental health issues prevalent in the legal industry.

The group plays host to a variety of programmes, each centred around promoting mental wellness. These include the Peer Support Group (PSG) programme, where student volunteers are trained by professionals to form an additional support system. The group also conducts events related to commemorating World Mental Health Day, animal-assisted learning, focus group discussions, workshops and more. Beyond that, the members produce videos and resources where guests speak candidly on issues such as the emotional toll of training contract season, depression, anxiety, stress and imposter syndrome.

The Commercial Law Careers Society (CLCS) is dedicated to equipping future commercial lawyers with essential resources, guidance and a supportive network.

Undergraduate Programmes

Whether you pursue a four-year Bachelor of Laws (LLB) degree or any of our Double or Concurrent Degree programmes, you will be assured of a quality legal education at NUS Law.

Bachelor of Laws (Honours) Degree (LLB)

Most of our LLB students enter NUS Law after completing their pre-university studies.

Successful completion of the LLB programme leads to the award of the following classes of degrees: First Class Honours, Second Class Honours (Upper Division and Lower Division), and Third Class Honours.

The LLB degree is recognised for admission to practise in Singapore*. Our graduates have also been admitted to practise in Malaysia, in several Commonwealth jurisdictions such as Australia, Canada and the United Kingdom, and in some states in the US.

Curriculum

Students in the programme must complete a minimum total of 160 units in four years. Around half of the required courses in the LLB programme are compulsory common law courses that are critical for legal practice.

Visiting Professors


Every year, NUS Law hosts over two dozen visiting professors. They come from some of the top universities in the world, including Harvard, Yale, Oxford, Cambridge, the LSE, Melbourne and Hong Kong University.

Our international visiting faculty conduct classes in their areas of expertise. By bringing their unique perspectives to the legal education offered by NUS Law, they add to the cosmopolitan nature of our school.

Non-Law Course and Minor

NUS Law students also benefit from being enrolled in Singapore's only fully comprehensive university, one that offers truly diverse subjects ranging from aquatics to theatre studies, nano-science to e-finance, across our 17 faculties and schools. Students are allowed to read non-law courses up to a maximum of 40 units; and students may choose to specialise in a targeted non-Law Minor. Minors like Business Analytics, Communications & New Media, Economics, and Management perfectly complement Law and ready our graduates for a future in which law is not practised in isolation.

To declare a Minor, the student must fulfil a specified minimum number of units in the minor discipline. Currently, students can choose from over 60 minors offered by our Business School, Faculty of Arts & Social Sciences, Faculty of Science, as well as College of Design and Engineering, just to name a few.

Double Degree and Concurrent Degree Programmes

Double Degree in Business Administration (BBA (Hons)) & Law (LLB (Hons))

The double honours degree in Business Administration and Law is a five-year programme offered jointly by NUS Business School and NUS Law. The programme is established in line with NUS' aim of attracting the best students from Singapore and around the world, who are keen on having a quality education and leveraging interdisciplinary opportunities in a university ranked amongst the world's best.

Double Degree in Economics (BSocSci (Hons)) & Law (LLB (Hons))

The double honours degree in Economics and Law is a five-year programme offered jointly by the Faculty of Arts & Social Sciences and NUS Law. Economics and Law are, in some areas, complementary disciplines. Singapore is a regional centre for legal services, and much of our international legal work involves commercial, corporate and financial law. This means there is—and will continue to be—a demand for lawyers with a strong background in economics, as well as for economists trained in law. Likely future employers include law firms, large commercial banks and institutions such as the Monetary Authority of Singapore and the Competition Commission of Singapore.

Concurrent Degree in Law (LLB (Hons)) & Master in Public Policy (MPP)

The concurrent degree programme in Law and Public Policy offers Law students, particularly those interested in a career in the legal, civil or foreign service, the opportunity to complete in four-and-a-half years, two degrees that normally take six years to complete if pursued separately. The Lee Kuan Yew School of Public Policy helps its students to understand the complex issues that challenge policymakers daily and offers a strong curriculum anchored firmly within an Asian context. NUS Law, on the other hand, offers rigorous training in public law, international law, and governance, and has a long history of placing its graduates in leading positions within the government and public service.

Special Programmes

Law-Ridge View Residential College Programme (RVRC)

The RVRC Programme is a two-year residency which takes an integrated interdisciplinary approach, designed to cultivate students' holistic development to help them prepare for, and embrace, life in the university and the work environment after graduation. The key to the unique RVRC integrated curriculum is the value of interconnectivity between knowledge building and the role of interaction and conversations within the learning community. At RVRC, co-academic activities are well integrated and interconnected to become the catalyst for strategic learning outcomes beyond the classroom.

Law-University Town College Programme (UTCP)

The UTCP is a multidisciplinary academic programme offered in Acacia College, College of Alice & Peter Tan, Residential College 4 and Tembusu College at University Town. This unique programme offers students an opportunity to read prescribed electives outside their majors and pursue other subjects of interest, while living and learning with the College community. Through this programme, students will develop strategies for clear and impactful writing skills, to chisel their inquiry and critical reasoning skills. It also grooms them to be able to clearly articulate their ideas on issues that are of global and Asian concern.

NUS College (NUSC)

The NUSC curriculum empowers students to be global-minded problem solvers who are ready to learn across boundaries and collaborate with others to make an impact on the world. To achieve this, NUSC offers students a holistic and interdisciplinary education which is delivered in small group seminar-style classes, intertwining living and learning. A wealth of diverse perspectives, local and global, are woven into the curriculum. Experiential learning programmes and dedicated moments of reflection are also integral to the curriculum, to develop cross-cultural competencies and foster personal development in students by encouraging them to be curious, critical, open-minded and adaptable.

Exchange Plus Programme

The Exchange Plus Programme allows students to graduate in four years with the NUS LLB and a master’s degree from an overseas university.

LLB-LLM option. Student Exchange Programme

The Student Exchange Programme offers an excellent opportunity to study the laws of a foreign legal system up close. During exchange, students can also immerse themselves in different cultures, build new connections, and enjoy the chance to travel.

Students in the LLB (Hons) programme may spend either one or both semesters of their third year in one of our partner law schools. Students in the Concurrent Degree Programme may spend one semester of their third year in one of our partner law schools, and students in the Business Administration (BBA (Hons)) & Law (LLB (Hons)) Double Degree Programme may spend one semester of their fourth year in an NUS Business School partner university. Due to the programme structure, the Student Exchange Programme is not available to students enrolled in the Economics (BSocSci (Hons)) and Law (LLB (Hons)) Double Degree Programme.

NUS Law also hosts more than 100 incoming exchange students from our partner universities each year, adding to the vibrancy of the law school.

Those who possess equivalent high school qualifications, which are in the non-English medium, are required to submit proof of their proficiency in the English language. International applicants presenting the International Baccalaureate (IB) are required to meet the stated admission requirements.

Double Degree Programmes

For Double Degree programmes, applicants must meet the admission requirements of both NUS Law and NUS Business School, or College of Humanities and Sciences.

Application Procedures

The NUS Office of Admissions (OAM) administers all applications for undergraduate programmes. Different application deadlines and procedures apply to different categories and high school qualifications. For more information, please visit nus.edu.sg/oam/. Under “Apply To NUS”, please select the relevant category to file your application.

Shortlisting and Selection

To be considered for the shortlist, applicants should indicate Law as the first or second choice (only if your first choice is a course that also requires an interview, e.g. Medicine) under the choice of courses. If you are interested in the Double Degree Programmes or Concurrent Degree Programme, you should opt for these in the same application form.

Written Test and Interview

Shortlisted applicants will be required to sit for a written test and may be invited to attend a formal interview, which will be held in April 2026 in Singapore. Selection shall be solely within the discretion of the University and will depend upon the number of places available in the Faculty.

The objective of the written test is to assess applicants based on three foundational competencies. These competencies are:

- (a) reading comprehension (the ability to understand complex pieces of text)
- (b) effective writing (the ability to express thoughts clearly in good written English)
- (c) analytical reasoning (the ability to process and organise information to solve a problem)

Tuition Fees

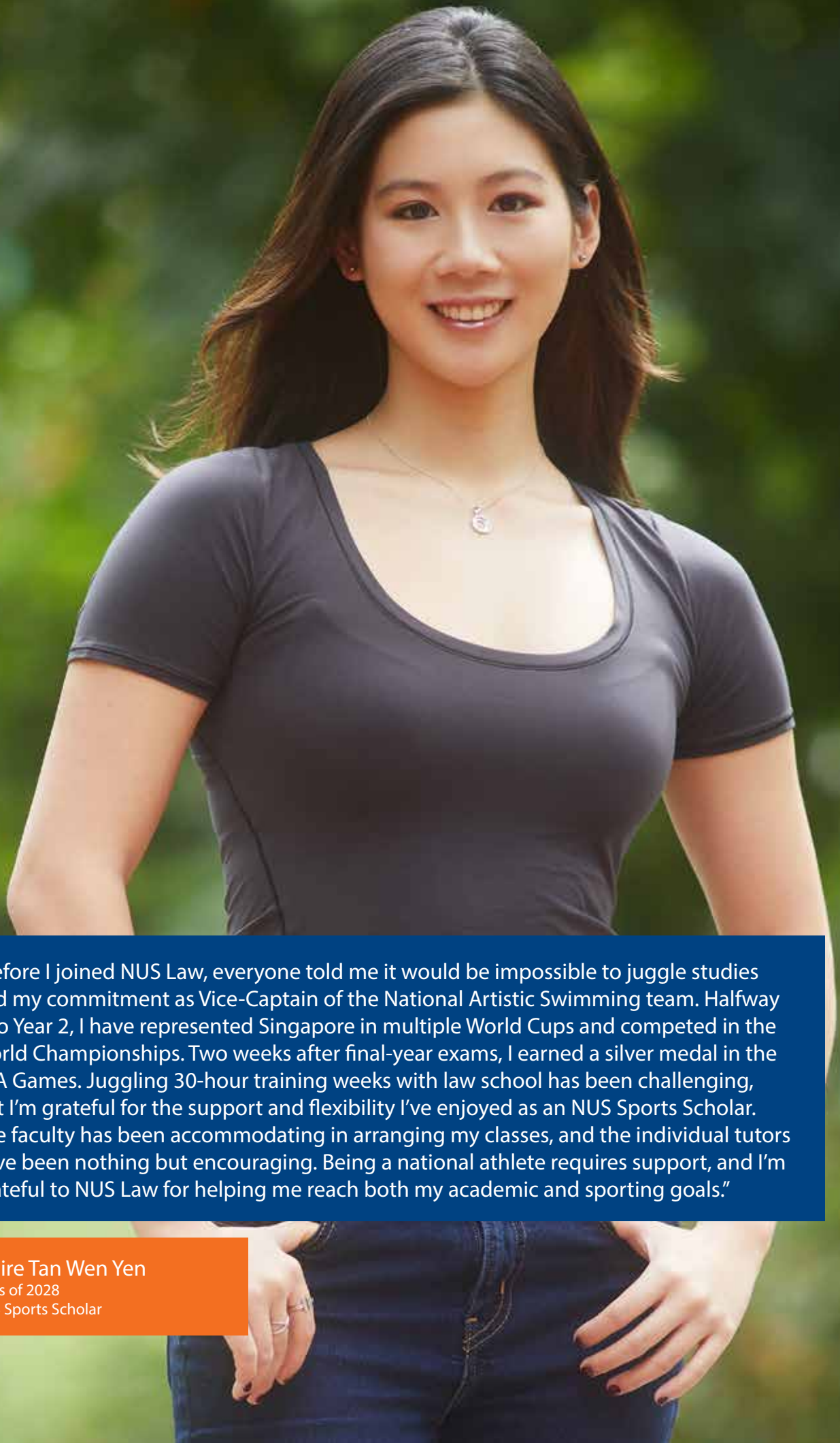
The cohort-based fee system has been implemented since Academic Year (AY) 2008/2009. Under this system, tuition fees for the new undergraduate intake cohort of students will be fixed throughout the student’s entire candidature. This enables students to better plan for the financing of their undergraduate studies.

The table below reflects the applicable fees (per annum amount) for the Undergraduate Intake Cohort of AY 2025/26.

Centre for Future-ready Graduates

CFG@Law organises a number of events throughout the academic year, including 'Career Paths in Law' Panel Discussion for freshmen, the Law Careers Fair, as well as fortnightly Lunchtime Careers Talks and industry-specific Panel Discussions. CFG also manages NUS TalentConnect—an online platform for Law students, alumni and employers to share and access internships, fellowships, practice training contracts and other permanent job opportunities.

CFG@Law fosters networking with alumni and co-ordinates the Law Alumni Mentor Programme (LAMP). It also promotes

close contact with industry partners, by inviting them for various initiatives.

Internships

NUS Law encourages students to acquaint themselves with legal work through vacation internships with local and foreign law firms, companies, institutions, the Legal Service and other government authorities. Almost all our current students undertake an internship during their time at NUS Law, and there is no lack of internship opportunities available.

Students who matriculate in the academic year 2025/2026 or later will be required to complete a minimum 2-week long legal internship. This compulsory requirement ensures that all new students will gain practical legal experience, while allowing NUS Law to continue to offer flexibility for students to use their vacation time for other pursuits, such as voluntary work or exploring broader interests outside of the required internship.
